Most of the teachers use Google Classroom for their teaching activities, and the district currently backs up around 9 TB of data.

The Challenge

Tinton Falls School District, located in New Jersey, needed a reliable solution to back up and restore their Google Workspace content for over 3,000 users. The district relies heavily on Google Workspace for daily operations, including emails between colleagues and parents, lesson plans, student documents, and classroom interactions. However, they found that Google's built-in solution, Google Vault, was neither fast nor user-friendly enough for their needs.

The school district faced challenges finding an efficient method to protect their critical data against accidental deletions, ransomware attacks, and other data loss events. According to Dennis Gilliand-Duarte, Network Administrator of Tinton Falls District, once something was deleted in the trash, it was irretrievable, with no other backups readily available. This was a particular concern for teachers who had collected a decade's worth of presentations, documents, and other teaching materials, the loss of which would result in disaster.

As for confidential data like student information, this was stored in the cloud but usually discussed via email, which opens any classified data like an Individualized Education Plan (IEP) for example, to the risk of exposure. Trusting that every faculty or staff member stayed vigilant over their emails was, therefore, also an issue for Dennis. "There are multiple times where I have sat down on somebody's computer," he shares, "And lo and behold, their email pops up. If I were somebody else, I could just delete every single email in there, I could forward every single email."

For Dennis, business continuity – or, in their case, teaching continuity – was a top priority. If, for example, a teacher lost their lesson plans due to accidental data deletion (or worse, a widespread cyberattack), this would have implications on student learning and longterm success. While the teacher scrambled to re-create coursework, quality of learning would decline, parents would become concerned and teachers would face burnout, in an increasingly difficult market to find and retain educators.

To avoid hypothetical situations like those, Tinton Falls required a solution that could provide automated, reliable backups and fast, granular restores to ensure continuity and compliance with data retention policies.

The AvePoint Solution

AvePoint Cloud Backup for Google Workspace provided Tinton Falls School District with a comprehensive solution to their data protection needs. The implementation process was straightforward, and AvePoint's team guided the district through each step, ensuring a smooth transition.

Dennis also praised Cloud Backup's ease of use and pointed out that six to eight months ago, when Tinton Falls was still searching for vendors, AvePoint was the only one offering backup for Google Classroom.
