

AVEPOINT SWEEPSTAKES 2019

Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility: The AvePoint Sweepstakes 2019 (the "Sweepstakes") is open only to registered attendees of Microsoft Ignite 2019 taking place between November 4 and November 7 at the Orange County Convention Center, Orlando, FL, who are at least eighteen (18) years old at the time of entry. AvePoint Community Champions, employees of Sponsor as well as any Microsoft Ignite sponsors and exhibitors, their subsidiaries and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and to Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning the prize is contingent upon fulfilling all of the requirements set forth herein.
- 2. Sponsor: AvePoint, Inc., 525 Washington Blvd., Suite 1400, Jersey City, NJ 07310 ("Sponsor" or "AvePoint"). AvePoint is a global leader in infrastructure management software solutions for the Microsoft SharePoint platform. AvePoint specializes in comprehensive data protection, disaster recovery, replication, migration, administration, archiving and compliance solutions for all Microsoft SharePoint Products and Technologies and sells such products exclusively to business clientele, government organizations and non-profit entities.
- 3. Timing: The Sweepstakes begins on November 4, 2019 at 9:00 a.m. Eastern Standard Time ("EST") and ends November 7, 2019 at 3:40 p.m. EST (the "Promotion Period"). The winner will be chosen by drawing. The drawing will be held at 3:45 p.m. EST on November 7, 2019 in front of the AvePoint booth number 913 at the Microsoft Ignite 2019. Participants must be in attendance at the drawing to be qualified to win and must present the winning raffle ticket to Sponsor at the time of drawing.
- 4. How to Enter: Registered attendees are eligible to enter by visiting AvePoint Booth number 913 and communicating a willingness to participate in the Sweepstakes to an authorized representative of Sponsor. To qualify for a prize, registered attendees must have their event badge scanned to receive a raffle ticket and is required to drop the perforated side of the raffle ticket in the designated container at the Sponsor's booth before the end of the Promotion Period. The prize is not redeemable in cash and must be accepted as awarded.
- 5. Drawing: Sponsor's decisions as to the administration and operation of the Sweepstakes and the selection of the potential winner are final and binding in all matters related to the Sweepstakes. Sponsor will randomly select the potential Sweepstakes winner from all eligible entries received during the Promotion Period, on November 7, 2019 at 3:45 p.m. At the time of Prize Drawing, the winner will be announced and given an opportunity to come forward. If the announced winner does not step forward and present the winning raffle ticket to Sponsor, that winner will be disqualified and, at Sponsor's sole discretion at the time of drawing, a new winner will be chosen. The potential winner will be required to sign and return to Sponsor, within ten (10) days of the date notice or attempted notice is sent, an Affidavit of Eligibility, Liability & Publicity Release ("Affidavit") in order to claim his/her prize. In the event that the potential winner is disqualified for any reason, Sponsor will award the prize to an alternate potential winner by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held after which the Prize will remain un-awarded.

Sponsor reserves the right to substitute the prize for one of equal or greater value if the designated prize should become unavailable for any reason. - 7. The potential winner may be required to show proof of identity before being awarded the Prize. The winner will be responsible for all applicable taxes, title, licensing, fees and shipping costs. by Sponsor in its sole discretion. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in a future sweepstakes by Sponsor.

Disputes: Except where prohibited, entrant agrees that all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State Florida without giving effect to any choice of law or conflict of law rules (whether of the State of Florida or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Florida.
